Pictures – Getting individual and group pictures taken for families to purchase. Evans to check with Cheri Bales to see if this is a possibility.

T-shirt sales – Make a t-shirt available that shows band membership. Students could wear on pep or marching band days or just to show band pride.

Chris Sargeant has communicated that she would like to get out of the concession stand duties. She will be happy to train a new volunteer and decrease responsibilities slowly.

The question whether we ever got our share of the Fund Walk funds was raised. Stuart will look in to it when he gets access to our accounts.

#### **New Business:**

Stuart would like to get rid of large, old computer that he acquired with the treasurer position. He would also like to get an updated version of QuickBooks so he can continue the good work that was started last year. Kasperski volunteered to ask James Weiss about these things.

## **Director's Report:**
